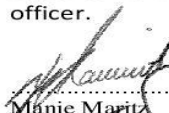
The above mentioned Accounting Firm is the Accounting officer of the above mentioned Company appointed from 2013/02/01

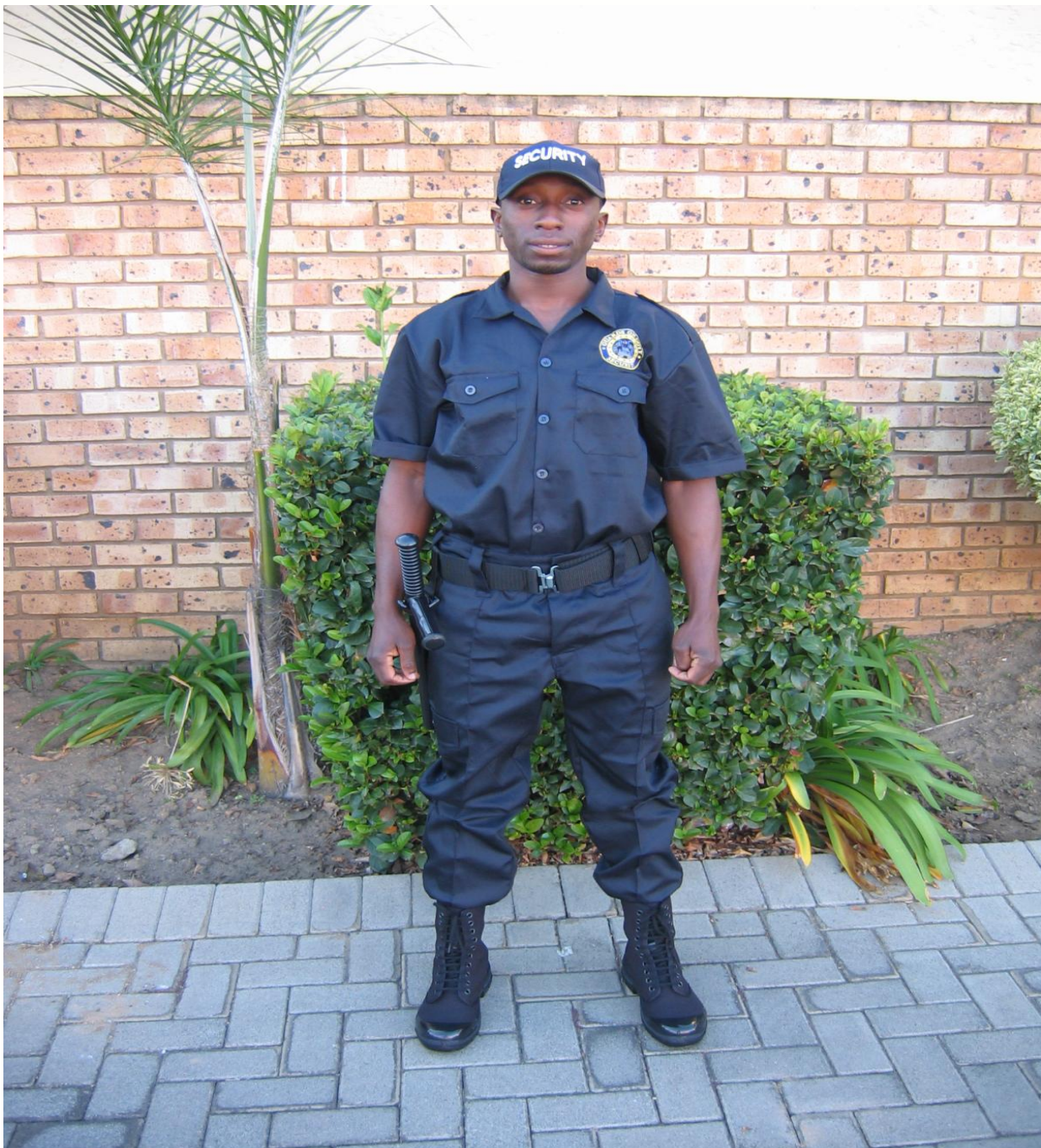
