Our Monthly Accounting Packages

1. Normal package - R1000 per month (Non-VAT vendor)

On this package you get your monthly accounting and then pay additional for the provisional tax returns in the months that they occur (2x per year) and you also pay separate for your income tax return at the end of the year. These returns are R850 each. You also then pay separately for your

financial statements at the end of the financial year, amounting to R4500. The annual return of R250 with CIPC is also not included.

2. All inclusive package - R1600 per month (Non-VAT vendor) for the financial year

All the above mentioned services are included in this package and you do not pay for anything else during the financial year.

If you are a VAT vendor, the cost is R800 additional per month..

We also assist with payroll @ R70 per employee which includes the payslip, EMP201 and UIF declaration with the department of labour. You then pay separately for the bi-annual and annual recon with IRP5's being R350 per employee per submission. So it will be R700 per employee extra per year. If you want the bi-annual and annual recon with the IRP'5 to be included in the package, it will be R95 per employee per month and all the above is included. You save R400 per employee.

No surprise bills! You know what you pay for which enables you to budget accordingly.
