TERMS AND CONDITIONS

1.	Makeup lessons: only the clients for whom the bookings have been made will be allowed in the room during the workshop.
2.	50% deposit required on all services, non-refundable.
3.	Full settlement of bookings made needs to be paid at least 4 days before the day of the makeup application services.
4.	All bookings are made on a 1st come 1st serve basis. No bookings will be reserved without deposit payment received.
5.	Any cancellation on paid bookings made, will not be refundable, this includes the deposit and full balance paid.
6.	All prices on items for the kits are market related and can be changed at any time without notice.
7.	Booking Time: All person(s) for makeup applications including group workshops must be at the same location and consecutive in time (no gaps in between).
8.	Delays: Late fees of R 50, 00 (fifty Rand) per half an hour, will be charged for any delays after the agreed upon hour; paid in cash on site. An invoice will be provided.
9.	A grace period of 30min will be provided in case of any emergency including the client and makeup artist.
10.	Satisfaction Guaranteed: makeup will be completed to client's satisfaction but is not to exceed allotted time.
11.	Traveling: any makeup service is done at your required premises on which the traveling fee is based upon the AA-Rate
12.	Liability: all brushes, tools and makeup products are kept sanitary and are sanitized before every makeup application. A new set of cosmetics and tools are used on every individual.
13.	Allergens: Makeup products used are skin care based and/or hypoallergenic. Any skin condition should be reported by the client to the makeup artist prior to application. Client(s) agree to release the makeup artist, Fine Line Beauty, its owners, and all employees and agents from liability for any skin complications due to allergic and/or unknown reaction.
14.	Severability: if any provisions of this agreement shall be held to be invalid, illegal, unenforceable or in conflict with any of the law(s) of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.
